Chairman's Report 2013

The Executive has pleasure in presenting the Annual Report and Statement of Financial Performance for the year ending 31st December 2013.

The income for the year was \$36,984 with expenditure of \$8,553, which included \$3,367 of unrealised loss on the investment in Mighty River Power shares. These shares were purchased on the strong dividend forecast and also in support of one of our major sponsors to Rowing NZ. Total accumulated funds increased by \$28,431, bringing the total to \$514,730 including \$38,731 in available income, being income from invested funds in previous years.

The Executive continues to explore the possibilities for increasing overall capital, particularly in the area of Corporate and philanthropic donations.

Over the past year the Foundation has sent out two newsletters and is very pleased to report that the Honours Board of Elite donors is now hanging in the entrance way to the RNZ High Performance Centre at Karapiro. Our thanks go to the past Chairman Bruce Fraser for his kind donation to cover the expenses associated with the honors board, plus also his enthusiastic efforts over the previous two years as Chairman in advancing the capital sum and general presence of the Foundation.

The Rowing Foundation is the property of the Associations, with one of the prime objectives being to build a capital sum over time which will enable annual grants to our promising Junior and Under 23 athletes, as well as any other projects identified as being within the scope of our constitution which would benefit rowing. We need the continued support from the rowing community in the various Association catchment areas to assist the Executive in making this feasibly possible. We encourage you to publicise the presence of the Foundation, to assist in increasing the donor contributions to the capital funds.

NOTES TO THE FINANCIAL STATEMENTS FOR THE YEAR ENDED 31 DECEMBER 2013

The following notes are part of and are to read in conjunction with these Statements of Financial Performance and Financial Position for the New Zealand Rowing Foundation Inc. for the year ended 31 December 2013.

1 Statement of Accounting Policies

The Foundation was incorporated in 1981 and was registered under the Charities Act 2005 in 2008. The Registered number is CC27098.

(a) Differential Reporting

The Foundation is a qualifying entity within the New Zealand Institute of Chartered Accountants differential reporting framework. The Foundation qualifies under the size criteria. The Foundation has taken advantage of all differential reporting concessions available to it.

(b) Statutory Base

The Financial Statements are prepared in accordance with the Institute of Chartered Accountants of New Zealand Reporting Standards.

(c) Measurement Base

The measurement base adopted is that of historical cost less depreciation where applicable.

(d) Goods & Services Tax

The Financial Statements are prepared on a GST inclusive basis. The Foundation is not registered for GST

(e) Change of Accounting Policies

There have been no material changes in the accounting policies during the year.

(f) Impairment Adjustment

The Executive Board has reviewed the value of all assets of the Foundation as shown in the Balance Sheet. Where necessary, and as disclosed in the notes to the accounts, any impairment adjustments or revaluations have been reflected in the Statement of Financial Position and the Balance Sheet."

2 Transfer to Capital Fund

In accordance with Clause 9 of the Constitution and Rules of the Foundation all donations less Re-launch expenses have been transferred to the Capital Fund.

3 Loan to New Zealand Rowing Association Inc. (NZRA)

A Deed of Acknowledgement of Debt dated 12 February 2010 provides for the following:

- (a) The NZRA is indebted to the Foundation for the principal sum of \$320,000;
- (b) The principal sum is repayable upon demand being made by the Foundation;
- (c) Interest shall be payable annually by the NZRA on the principal sum unless that payment has not been demanded by notice in writing by the Foundation to the NZRA. No demand for an interest payment or principal repayment has been made by the Foundation during the year ended 31 December 2013.
